### Global Young Professionals' Academy - Become a sponsor!

The Global Young Professionals' Academy led by the International Organisation of Employers (the Academy) is an annual training session for 25 carefully selected young professionals under the age of 35 already working or aiming to work in employers' and business membership organisations (EBMOs) around the world.

The Academy aims to **build the capacity and skills of young professionals** as intrapreneurs, to enable them to effect change and advance their careers within their organisations upon their return.



#### **AREAS OF TRAINING**

Through the Academy the selected young professionals will:

- ✓ Acquire tools to implement and adapt policies at national/local level
- ✓ Gain advocacy skills to engage more effectively with governments and stakeholders
- Receive guidance to achieve greater policy impact
- ✓ **Continue to be inspired** by the work of the global alumni network

#### Background

EBMOs like the National Federation of Maldivian Employers are the backbone of business in many local economies. They bring independent companies and smaller representative bodies together with a shared vision to improve the environment for doing business in their respective countries. To do so, they engage with governments and other stakeholders to review and intervene on social, employment and business-related policies.

However, many EBMOs, particularly from Least Developed Countries (LDCs), often lack the resources to adequately train their staff and have insufficient capacities to develop, modernize and professionalize their organisations in line with the latest skills, technological and human capital developments. It is key for EBMOs to have adequately trained staff to advance the overall environment for doing business, with a view to foster entrepreneurship and economic growth.

The Spanish Employers' Confederation (CEOE) jointly arranged the 2017, 2018, and 2019 sessions of the Academy in Madrid, Spain. IOE proposes to jointly organize this prestigious Academy with the National Federation of Maldivian Employers for the 2020 session, to take place in Malé, Maldives at the discretion of NFME.

#### About the course

The course has a two-phase structure:

- 1.A **2-week online distance preparation module** using a digital platform created by the International Training Centre of the International Labour Organization (ITCILO)
- 2.A face-to-face session which will take place in Malé, Maldives where young professionals will learn by means of case studies, simulation trainings, quizzes and presentations

After the Academy, professionals join a global network and can represent their organisations at regional and international conferences. **Over the past three years, young professionals from 40 different countries** have been trained with this programme.
